**3 - ANNOUNCEMENT OF THE OPERATION.** The Operation will be advertised to the public on the website and social media of the Organising Company, and by distributors.

Only Participants who successfully fulfilled all the necessary requirements between 1<sup>st</sup> October 2023 and the 31st March 2024, will be retained to participate in the Operation.

- **7 ENTRY REQUIREMENTS.** In order to enter the Operation, the Participant must comply with all the following rules:
  - 1. Purchase a Bahco screwdriver or a screwdriver set (except wooden handle screwdrivers and electrical testers) at a distributor's store;
    - o Bahco screwdrivers can be purchased in a physical store or online.
  - 2. Fill-in personal details on the Landing Page;
  - 3. Upload the receipt to the Bahco Landing Page;
    - The receipt needs to be legally valid, as per local accounting requirements;

• The reference to the Bahco screwdriver, the name of the distributor and the date of purchase must be visible on the receipt.

The Participant must proceed to steps 1 to 3 above between 1st October 2023 and 31st March 2024.

### 8 - WINNER DESIGNATION AND INFORMATION.

The Winners will be selected randomly amongst Participants who correctly uploaded their receipt on the landing page, as described in Section 11.

**9 - AWARDING OF THE PRIZES.** The winners will be contacted by email to the email address provided in order to sign-up to the Operation.

In the event the Winner does not answer the email within three (3) calendar days from the date on which the message was sent, a second email will be sent. In the absence of a response from said Winner within 15 additional calendar days from the date of the second message, the Prizes will be considered lost and the Prize will not be put back in the Competition.

When the Winners are contacted by email, they will be asked to provide a complete postal address to which the Prizes may be sent. The Prizes will be sent to the winner(s) by post within sixty (60) days of being provided their postal address.
